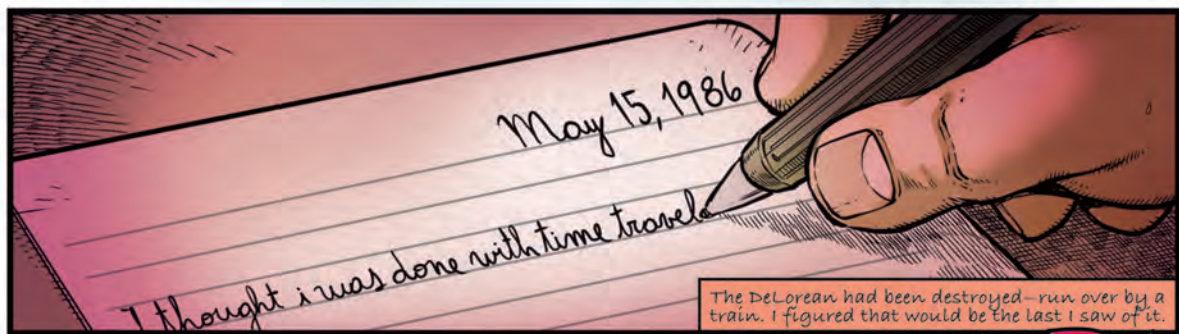

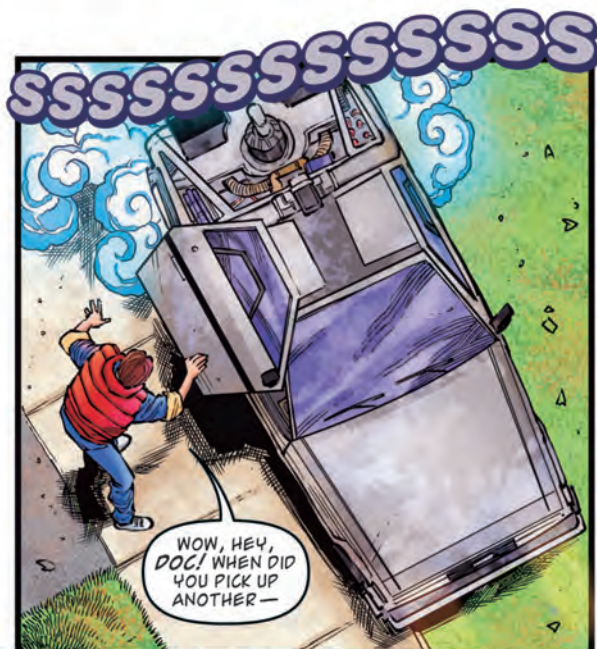

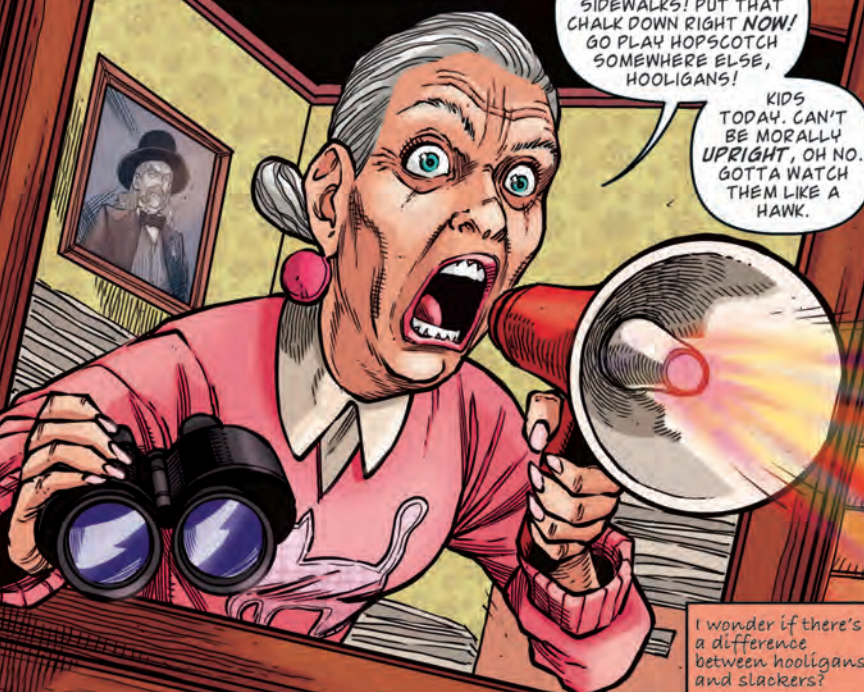
I'M SORRY. MUCH OF OUR ARCHIVES WERE LOST IN A FIRE, BACK IN THE '60S.

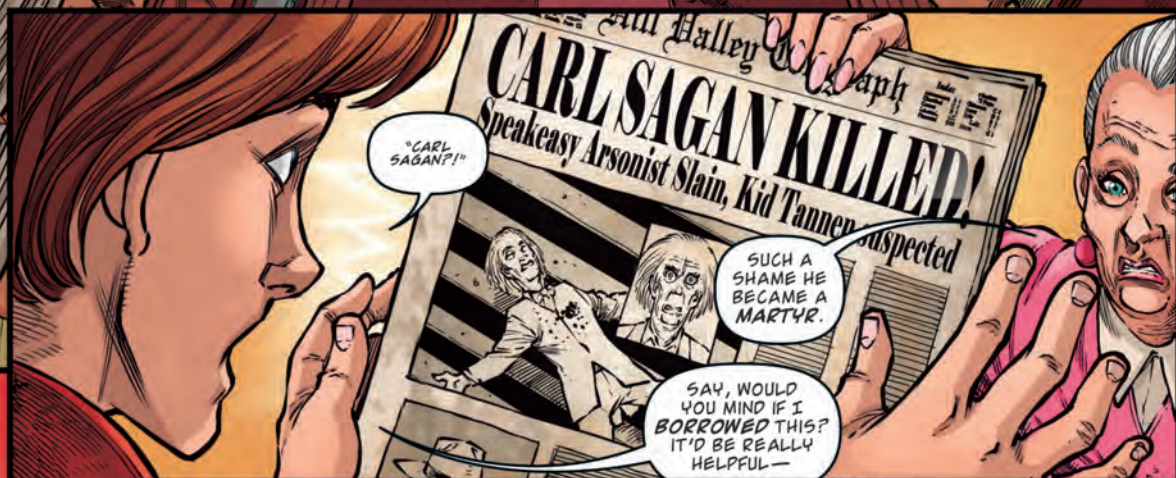
FACTS, HUH? WELL, YOU CAME TO THE RIGHT PLACE FOR THAT!

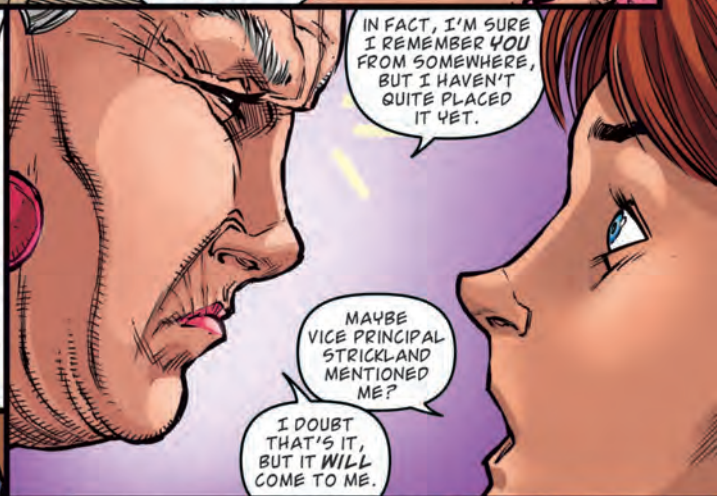
SUCH A SHAME HE BECAME A MARTYR.
