course--

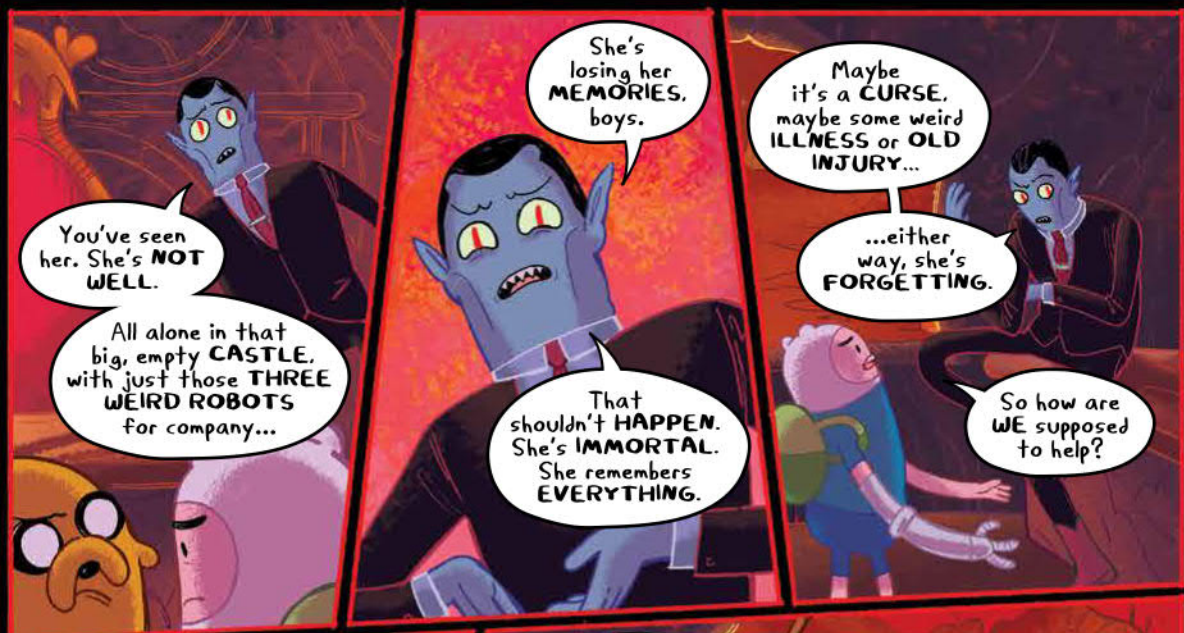
--why change

PEEPERS**.

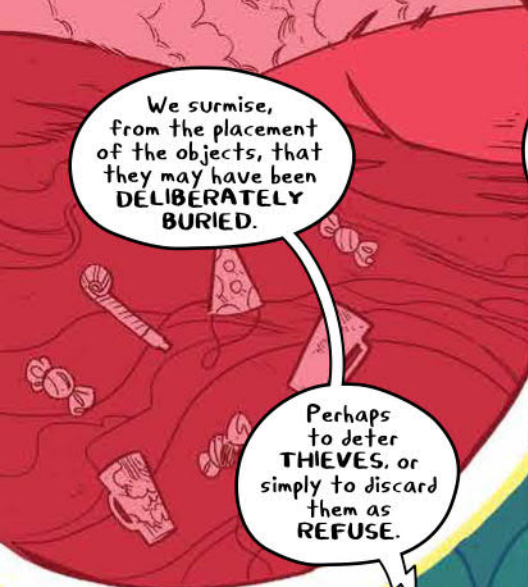
Early

objects.



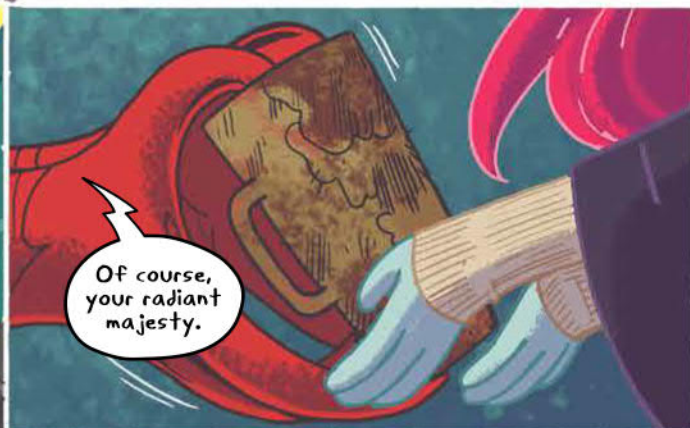
We surmise, from the placement of the objects, that they may have been **DELIBERATELY BURIED**.

Perhaps to deter **THIEVES**, or simply to discard them as **REFUSE**.

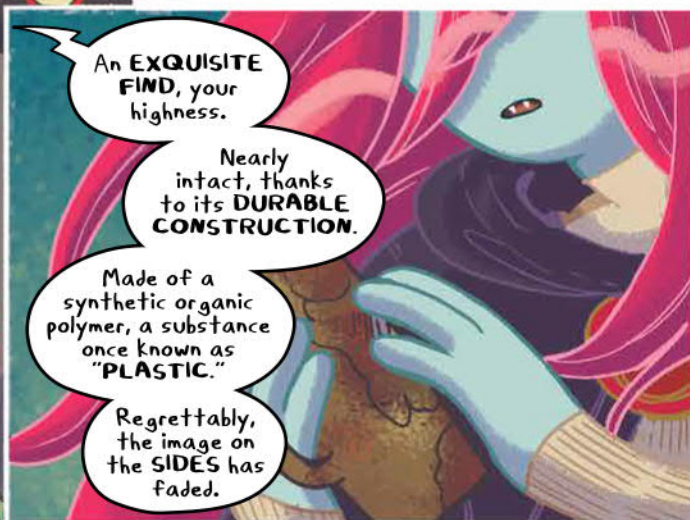


However, the lack of **OTHER** nearby objects suggests a one-time burial, rather than--
